**PLEASE POST FOR ALL FOOD SERVICE WORKERS**

All people who handle food or drinks (cafes, restaurants, gas stations, theaters, bars, taverns, daycare, nursing homes, etc) **must have a current food handler permit to be in accordance with Utah state law.** Successful completion of a separate exam is required to be in compliance with the Utah Food Safety Manager Certification Act (R392-101).

Food Handler Permit classes are to be held at TriCounty Health Department, 133 South 500 East, Vernal. Classes are held in Daggett at the Courthouse, 95 North 100 West, Manila, UT

There is a \$15.00 fee to attend a Food Handler’s class. The Food Handler’s Permits will be issued after attending a class and successfully passing the exam (**plan for 3 full hours**). Or you may choose to do course and test online at [www.statefoodsafety.com](http://www.statefoodsafety.com). The online program offers the course and test in multi languages. The fee for the online course is \$21.00. The permit is valid for 3 years. The Health Department will try to accommodate any special learning needs.

The fee for specially scheduled Food Handler’s Classes is \$200.00 plus \$15.00 per person.
